Description:

Honorary Membership is bestowed upon individuals who have made significant contributions to Arabic calligraphy, including patrons, scholars, and cultural ambassadors. This prestigious level recognizes exceptional support and promotion of Arabic calligraphy on a global scale.

Eligibility Criteria:

1. **Exceptional Support and Promotion:**
 - Demonstrable efforts in supporting and promoting Arabic calligraphy at a national or international level.
 - Examples include sponsorships, academic contributions, or public advocacy.
2. **Comprehensive Portfolio of Achievements:**
 - Documentation of achievements such as published research, books, or artistic works related to Arabic calligraphy.
 - Include copies or links to publications and notable works.
3. **Recognition from Cultural or Academic Institutions:**
 - Evidence of recognition through awards, honorary titles, or memberships from reputable cultural or academic organizations.
 - Official certificates or letters of recognition.
4. **Nomination Letter:**
 - A nomination letter from a UAC board member or a recognized cultural organization.
 - Must detail the nominee's contributions and impact on Arabic calligraphy.
5. **Detailed Proposal:**
 - A proposal comprising **500–1000 words**.
 - Outlining future contributions to Arabic calligraphy and how the honorary membership will facilitate further advancements.

Required Documentation:

Support and Promotion Evidence:

- Documentation demonstrating significant support and promotion of Arabic calligraphy (e.g., sponsorship agreements, advocacy initiatives).

Achievement Portfolio:

- Copies or links to published research, books, or significant artistic works.

Recognition Proof:

- Certificates, honorary titles, or letters from cultural or academic institutions.

Nomination Letter:

- A formal nomination from a UAC board member or a recognized cultural entity.

Future Contributions Proposal:

- An extensive proposal detailing planned contributions to the field of Arabic calligraphy.

Additional Requirements:

Application Submission:

- Applications must be submitted through the UAC Membership Portal or directly at the UAC Membership Office.

Verification:

- Comprehensive review of all submitted documents to ensure eligibility and validate contributions.
